How You Can Take Action

To find your Legislators: Go to this link, and enter your address: http://azredistricting.org/districtlocator/

- Email: Write a message of support or opposition of a bill to your legislators. Sample template included in toolkit.
- Social Media: Follow your elected officials on Twitter and Facebook. You can also social media to post your opposition or support of a bill and tag your legislators.
- Create: a Request to Speak account and file your position on a bill.

Dear Representative John Doe,


- Requiring voters to sign their early ballot affidavit in front of a notary.
- Requiring the voter or voter's agent to show ID when dropping off an early ballot.
- Eliminating the ability for family members and household members to drop off an early ballot.

Personally, I am affected by this bill because I live by myself and I do have caregivers that come in to assist me. However, they are with me only a couple hours a day. I do not feel comfortable letting them know how I vote. This bill limits my accessibility options to vote. In my opinion, the current voting process already has too many barriers for me. Please vote against this bill so I do not have to deal with additional barriers.
