## **Chairs Report/Summary of Current Events**

Commissioner Kneifel made announcements to the community and the Board. Commissioner Kneifel welcomed Commissioner Judy Huch our new Audiologist Representative to the commission. Commissioner Judy Huch introduced herself to the board.



## **Executive Director's Update/Summary of Events**

ACDHH has been working on updating the interpreter licensure rules for the state of Arizona and has been to four different cities across the state gathering public comments and suggestions from both the hearing and deaf community. The thirty day written comments session is currently taking place and will end on March 13, 2016. A public comment email which was sent to the board by Deb Stone is available for Commissioners review. After the thirty day written comments session has ended, there will be an oral comments session that will take place at ACDHH on March 17, 2016. Both the oral and written comments ACDHH receives will be reviewed by the board for final approval prior to be handed over to the Governor's Regulatory Review Council.

A special meeting in April will need to take place to approve the proposed interpreter rule changes. Commissioners are able to attend by phone.

Sherri Collins mentioned the board vacancies. There are four vacancies all of which are Deaf representative positions. Two of the board's current commissioners are eligible for reappointment.

The Noisy Toys Awareness campaign that took place over the 2015 holidays was mentioned.

Sherri Collins attended the National Association for the Deaf Biennial conference which had around two hundred people attend. ACDHH staff was present with a booth set up and all in all this conference was a great success.

ACDHH's Specialists were mentioned and their highlights are available for the boards review.

The Arizona Commission for the Deaf and Hard of Hearing hosted the Black Deaf History Month in February which was a great success. The African American Symposium was also mentioned.

ACDHH and the National Association for the Deaf will hold a Legislative Training for the Deaf community. AZ interpreters will be able to earn continuing education units (CEUs). The training will take place on Saturday, March 5<sup>th</sup> at the Arizona Commission for the Deaf and the Hard of Hearing.

Sherri Collins spoke to the board about the new bill tracking system that is being put into place with the help of the commission's new lobbyist Rip Wilson. Arizona Senate Bills SB1284 and SB1166 were mentioned. A copy of a press release regarding SB1284 is available for the boards review.

At the October 2015 meeting the board was present for The University of Arizona's low income hearing aid program presentation. ACDHH is currently working with lobbyist Rip Wilson on the best policy approach to obtain coverage for Arizona low income citizens, who need assistance with hearing aid coverage. This program will also be discussed and presented to the Governor's Council on Aging during a meeting in May.

There is nothing unusual in regards to the budget at this time. No recommendation for changes were given in regards to ACDHH's finances.

ACDHH's new lobbyist Rip Wilson and the Commission's new Analysist from JLBC, Henry Furtick introduced themselves to the board.

RSA, AZ relay service and ACDHH partnered together for a lunch and learn for employers to understand the importance of video relay systems and other assistive technologies that can be used in the workplace. Commissioner Sue Kay Kneifel explained this event in more detail.

Commissioner Booth joined the meeting at 5:00pm.

## Looping at House and Senate- Funding

Commissioner Kneifel moved agenda item nine to agenda item five and continued with the agenda as written.



Sherri Collins provided the board with background knowledge in regards to looping at the Capitol for both the House and Senate buildings. Collins asked for the board to approve the funding for this project by using the commission funds from the fund balance. Discussion ensued between Commissioners Baber, Garcia, Kneifel, Baesler, lobbyist Rip Wilson, and Sherri Collins in regards to the location of the funds.

Commissioner Roadlander moved to approve the funding for the partnership in providing the looping with the house and senate. Commissioner Huch Seconded. The motion passed unanimously.

## **Public Comments on Agenda Items Only:**

No public comments at this time.

## **Licensure Complaints:**

Commissioner Baseler moved to go into a closed executive session, commissioner Baber seconded. The motion passed unanimously. The meeting entered closed executive session at 5:18pm.

Open Session returned at 5:27pm.

Emmett Hassen explained each complaint:

<u>Lilia</u> No last name: Complaint was made that the interpreter attended a medical appointment and interpreted without a license. Commissioner Garcia motioned to dismiss the complaint. Commissioner Roadlander seconded. Commissioner Huch and Commissioner Hebert abstained. The motion passed.

<u>Linda Bove</u>: Deaf client felt that the interpreter violated the code of professional conduct. Commissioner Lamer requested that Emmett Hassen give his recommendation on this complaint. Emmett Hassen stated there was no evidence of a violation of the code of professional conduct. Hassen recommended that the complaint be dropped with no further action. Commissioner Garcia motioned to dismiss the complaint with no further action. Commissioner Hebert seconded. Commissioner Huch abstained. The motion passed.



<u>Cynthia Busby:</u> Deaf client alleged that interpreter violated several codes of the professional conduct by taking jobs she wasn't qualified for. Commissioner Kneifel asks Emmett Hassen to give his recommendation on how to handle this complaint. Hassen suggested that the board dismiss this complaint with no further action. Commissioner Baber motioned to dismiss the complaint with no further action. Commissioner Booth Seconded. Commissioners Huch and Hebert abstained. The motion passed.

<u>Diane Riddick:</u> Interpreter allegedly violated several tenants of the CPC by not showing up to an assignment. Emmet Hassen stated that both tenants 6.0 and 6.4 show evidence to the complaint and he recommended that the interpreter take professional development courses rather than suspending or revoking the interpreter's license. Discussion ensued between Commissioners Hebert, Baesler, Garica and Kenifel. Commissioner Baesler motioned that the interpreter take professional development courses related to ethics and or business. Commissioner Booth seconded. Commissioner Kneifel asked for clarification on a specific number of hours. Commissioner Baseler amended that the interpreter take 0.5 CEUs. Commissioner Booth Seconded. Commissioners Baber and Huch abstained. The motion passed.

Commissioner Lamer left the meeting at 5:45pm.

<u>Darcy tucker:</u> Deaf client alleged that the interpreter violated the code of professional conduct by accepting jobs that she wasn't qualified for. Emmett stated that there was no harm done and recommended that the board dismiss the complaint, in addition the interpreter should receive a written letter, asking that the interpreter gather further information before accepting assignments. Commissioner Baber motioned that the complaint be dismissed with no further actions. Commissioner Baesler Seconded. Commissioner Huch abstained. The motion passed.

<u>Vernice Williams-Thomas:</u> Deaf client alleged that the interpreter violated the code of professional conduct by working without a license. Emmett recommended the filing of a cease and desist letter with the state of Arizona so that the interpreter cannot work in the state of Arizona. Commissioner Baesler motioned that a cease and desist letter be put on file in the state of Arizona. Commissioner Roadlander seconded. The motions passed unanimously.



## Licensure: proposed rules update

A special meeting will take place on April 12, 2016 at 4:00pm, to address the updated interpreter rule changes. Commissioners are welcome to attend the meeting by phone.

## **Interpreter Fund:**

Sherri Collins explained the BEI interpreter exam to the board. Collins requested that the board approve the funding for this test by using the interpreter fund in the amount of 255,000\$. Discussion ensued between Commissioners Booth and Garcia in regards to the location of said funds. Commissioner Garcia motioned to approve the staff to utilize the interpreter fund for the BEI proposal. Commissioner Huch seconded. Commissioner Hebert abstained. The motion passed.

## Officer Elections:

Commissioner Kneifel proposed to table the officer elections until there is a full board. Commissioner Roadlander motioned that officer elections be tabled until a meeting which all commissioners are present. Commissioner Garcia seconded. Commissioner Baesler abstained. The motion passed.

#### 2016 Meeting:

Discussion ensued between the full board on dates that could potentially work for upcoming meetings. Commissioner Baesler motioned that the board set the 2016 meeting schedule with the following dates: Special meeting on April 12, 2016 at 4:00pm, May 5, 2016 at 4:30pm, August 25, 2016 at 5:00pm and December 1, 2016 at 4:30pm in Tucson. Commissioner Baber Seconded. The motion passed unanimously.

Vicki Bond stated that the complaint process has not changed and any consumer is able to file a complaint if they believe an interpreter has violated the Registry of the Interpreters for the Deaf Code of Professional Conduct, or rules.

## **Executive Director's Update/Summary of Events Discussion only**

Executive Director Sherri Collins reported:

ACDHH hosted a Legislative training workshop via the National Association of the Deaf (NAD). More than 100 Deaf consumers attended. Purpose: educate on legislative process and how a bill is passed.

Members of ACDHH staff (Carmen Green, Emmett Hassen, and Vicki Bond) participated in Licensure Complaint Investigation training for Professional Development.

Michele Michaels attended an Annual Audiology conference.

ACDHH formed a new partnership with the Arizona Technology Assistance (AzTAP).

ACDHH updated and distributed a Consumer Brochure on T-Coils. It is also posted on the ACDHH website.

May is Better Hearing and Speech Month (BHSM) - Media focus: various print outlets.

Director Collins and other staff represented ACDHH in a national Deaf Grassroots Movement Rally at the capitol - 250 people attended. Media coverage focused on employment.

ACDHH vision for 2017 is mobilizing the community. February 2017 a public event is planned for Legislators to meet the Deaf and Hard of Hearing communities. We will hold our First Annual Legislative Awareness Day at the Capitol and ASDB will be included. This event will tie into ACDHH 40<sup>th</sup> anniversary. 2017 marks ACDHH 40<sup>th</sup> anniversary.

Arizona Relay Service (AZRS) sponsored a football and volleyball camp at Phoenix Day School for the Deaf (PDSD). Sherri Collins and Curtis Humphries represented ACDHH. Arizona Cardinals player Michael Floyd along with former NFL player J.J Birden coached PDSD students. Tony Tatum, Gallaudet All-star football player also gave instruction. Two All-Star volleyball players from Gallaudet University coached PDSD volleyball players.

Funding for looping the Arizona House, Senate and gallery is in the budget awaiting the Governor's approval. No other state House and Senate floors are looped.

Possible partnership with ASU to use \$750,000 fund for interpreters. Considered offering BEI testing here in Arizona. Decided this is not in our best interest. Would like to use funds for Deaf Interpreter and Tri-lingual interpreter certification testing.

**Jennifer Orozco-Walker** - Interpreter Orozco-Walker worked nine days without a valid license. Discussion ensued between Commissioner Kneifel and Commissioners Schneck, Hebert, Baesler, Jantz, Kneifel and Emmett Hassen.

Commissioner Baesler motioned she pay \$100 for work during that time, Commissioner Schneck seconded. The motion passed unanimously

**Jeriann Skinner** - Interpreter Skinner worked without a valid interpreter certification within a 53-day period of time. Certification has been reinstated at this time. Commissioner Kneifel asked for discussion. Discussion ensued between Commissioners Jantz, Hebert, Kneifel, Baesler, Huch, Baesler, Schneck, and Emmett Hassen.

Commissioner Jantz moved to enter executive session, Commissioner Schneck seconded. The motion passed unanimously

Commissioner Jantz proposed an amendment to use the second set of follow up questions. Commissioner Hebert seconded. The motion passed unanimously

**Sydney Rosell** - Interpreter Rosell, a Provisional C licensed interpreter worked alone on an assignment.

Public comments made by Owen Browder and Bryanna Browder.

Owen Browder: This was a post-op situation. I was relieved to see a live interpreter. I started to communicate, but the interpreter did not respond. My daughter was there and can speak to what she saw.

Bryanna Browder: March 2015 my father was scheduled for surgery at Banner Desert Samaritan hospital. No interpreter scheduled. VRI did not work. Hospital called interpreter for this planned non- emergency procedure. Interpreter was neither qualified, certified, nor licensed to work alone, as she holds a Provisional C interpreter license. She broke the law. My father's health and recovery were at risk. Three main issues. 1. Complaint against Rosell. 2. No standards for

agencies. AG's office dismissed our case. 3. Hospital had no back up for VRI issues. The agency and hospital used the emergency exemption for a planned procedure. Please send a message to community. Improve systems to safeguard the deaf community.

Commissioner Kneifel asked for discussion. Discussion ensued between Commissioners Hebert, Kneifel, Jantz, Booth, and Emmett Hassen..

## Commissioner Kneifel moved to enter executive session, Commissioner Jantz seconded. The motion passed unanimously

Entered executive session at 6:08pm. Resumed public session at 6:42pm

Commissioner Kneifel asked for discussion. Discussion ensued between Commissioners Jantz, Schneck, Hebert, and Emmett Hassen..

Commissioner Schneck moved Interpreter Rosell take an Ethics class and pay a \$100 fine. Commissioner Schneck again motioned that Interpreter Rosell complete a minimum 10hr Ethics class and pay a \$100 fine. Commissioner Huch amended the motion to add a possible suspension if Interpreter Rosell did not comply within 90 days. Commissioner Jantz amended the motion to send a letter to the agency from AG to cease and desist sending unqualified, unlicensed interpreters to assignments. Also, include training for the hospital staff on how to use interpreters and also have a back-up plan when technology fails. Commissioner Booth seconded. One objection - Commissioner Hebert

Assistant Attorney General Handy was dismissed

## VIIII. Executive Director's 2015 Evaluation:

Humphries clarified that the first goal for the Support Service Provider Program is to supplement existing services offered by COPD. ## **Utilization of Interpreter Fees and Funds**

Collins clarified that the utilization of ACDHH's interpreter fees and funds goes directly to the Support Service Provider and CART/Emergency Interpreters training.






## **Chairs Report/Summary of Current Events Discussion only**

Sherri Collins updated the board with 2017's highlights:

- Commissioner vacancies. Three Deaf Representatives and one Representative from the Arizona State Schools for the Deaf and Blind are needed.





- National Association of the Deaf Conference 2016 was a huge success. ACDHH attended the conference and a sensitivity training was held for the Phoenix Sky Harbor Staff.
- ACDHH teamed up with the Department of Emergency and Military Affairs (DEMA) for an emergency training where ten interpreters and three Communication Access Real-Time Translation Providers (CART) were prescreened and trained on emergency situations
- Carmen Green gave the board a brief summary of the "Patient Point Program" to the board.
  - Patient Point mean an integrated patient engagement solutions surrounding key points of care to help healthcare professionals improve health outcomes, efficiency and patient satisfaction. ACDHH created a commercial which helped explained cultural differences between Deaf and Hard of Hearing individuals in hopes that the hospital and medical staff will want to have ACDHH staff come to give sensitivity training to their offices.
- ACDHH's annual Noisy Toys campaign has kicked off and ACDHH had TV segments on the majority of Arizona Television Stations to inform the public of toys that could be harmful to children's hearing.
- Meeting with Director of Department of Economic Security (DES) to talk about the Deaf and Hard of Hearing individuals and issues that they are facing with services that fall directly under DES. ACDHH hopes to continue to work with DES to work on fixing these issues.
- the National Association of State Agencies of the Deaf and Hard of Hearing (NASADHH) and ACDHH will be meeting with Gallaudet University to discuss nationwide issues that concern the Deaf and Hard of Hearing Communities such as; Early intervention for Deaf and Hard of Hearing children, language acquisition, Interpreter licensure/training and Police training.
- The Arizona Association for the Deaf (AZAD) 80<sup>th</sup> Gala with be taking place this weekend and ACDHH staff will be in attendance.
- One on one meetings with the newly appointed Arizona State Legislators and Executive Director Sherri Collins are in the process of being scheduled.
- March 7, 2017 ACDHH will be holding a "Deaf and Hard of Hearing Day at the Capitol" which will tie into the Commissions 40<sup>th</sup> Anniversary celebration.




#### Case #1

Mr. Steven Roberts alleges that a misinterpretation occurred at his court appearance on November 12, 2015. According to Mr. Roberts, the interpretation indicated that the court would send him a form which he could pick dates and locations at which to fulfill his community service obligations. When Mr. Roberts did not receive a form or letter from the court, he returned to the court and asked the clerk for assistance. The clerk advised Mr. Roberts that he had not sent in the letter as instructed by the judge at the November court appearance, making him out of compliance with the court order and may have been placed in custody. Mr. Roberts alleges that a misrepresentation during his original court appearance was the cause of this misunderstanding.

#### Case #2

Mrs. Penny Roberts alleges that a misinterpretation occurred during an interaction with the Department of Child Safety (CPS) on December 1, 2015. Mrs. Roberts alleges that the interpreter indicated that Mr. Steven Roberts had molested his granddaughter, when the intended message was that the accused individual was Stephan, the Roberts' grandson. Mr. Roberts became very upset at the accusation and demanded medical tests be performed on his granddaughter to determine the validity of the accusation.

#### Case #3





Mrs. Penny Roberts alleges that Mrs. April Welch engaged in unprofessional conduct during an interaction with the Pinal County Superior Court on December 7, 2015. Mrs. Roberts alleges that Mrs. Welch had a private discussion with representatives from the Department of Child Safety prior to the meeting with DCS representatives and Mr. and Mrs. Roberts.

Commissioner Jantz moves that all complaints against Ms. Welch be dismissed. This includes case one, two and three. Commissioner Baber seconded. Motion passes unanimously.

#### **Jasmine Marin**

#### Case #1

Ms. Pfau-Johnson alleges that Ms. Marin conducted herself in an unprofessional manner not respecting Ms. Pfau-Johnson as an interpreter colleague or team. Ms. Pfau-Johnson felt that already being hired by the school district was not satisfactory to Ms. Marin's expectations or standards. Ms. Pfau-Johnson felt she was humiliated by Ms. Marin's demeanor in front of her student that she was assigned to work with.

#### Case #2


Ms. Sparpanic filed this complaint against Ms. Marin due to her unprofessional conduct in a public setting. Ms. Sparpanic felt uncomfortable with Ms. Marian when she approached her regarding another interpreter, Mr. Dylann Farney, who happened to be there at the event as well. Ms. Marin was allegedly attempting to discredit Mr. Farney's interpreter experience. Mr. Farney had been hired by a local school district to interpret for Ms. Sparpanic's deaf daughter. Moreover, Ms. Sparpanic felt that Ms. Marin did not maintain her professionalism while she provided a female teenager that she interprets for, keys to Ms. Marin's car. Ms. Marin was also "close" to this male consumer of her which she felt was inappropriate.

Discussion ensued between Commissioners Jantz, and Emmett Hassen regarding case number two against Ms. Marin

#### Case#3

Mr. Farney filed this complaint against Ms. Marin due to her unprofessional conduct in a public setting. Mr. Farney, as an educational interpreter, happened to be at the coffee shop where a deaf event was being held and noticed that Ms. Marin was speaking loudly to two individuals trying to discredit his interpreting experience. Mr. Farney believes that Ms. Marian was "out-of-line" because she didn't know him personally nor acknowledge that he had been hired by the Kingman Unified School District to interpret for Ms. Sparpanic's daughter.

Commissioner Baesler motions to table the complaints made against Ms. Marian until the board is able to receive more advice from the Attorney General's office. Commissioner Huch seconded. Commissioner Baber opposed. Motion carries.





## Stacy Zamora

Ms. Zamora's Provisional B license expired on September 10, 2016 and she reapplied with a new initial Provisional B application on October 25, 2015. In her response to questions asked on the application, she disclosed to working 8 days without a license beyond September 10, 1016. She contacted ACDHH licensing department for guidance and was advised that she was outside her 30 days to renew with penalty fee therefore she had to reapply as new. Upon learning that she did not qualify for Provisional B under the new rules, therefore she applied for a Provisional class C license. She submitted a letter for the board explaining her medical reasons.

Commissioner Jantz moves that a \$100 penalty fee be paid by Ms. Zamora. Commissioner Baber seconded. Commissioner Hebert opposed. Motion carries.

Commissioner Jantz moved to go into executive session for legal advice regarding Jennifer Orozco Walker, Jerriann Skinner, April Welch, Jasmine Marian and Stacy Zamora. Commissioner Baber seconded. Motion passed unanimously.

Jo-Ann Handy and Molly Bonsall from the Attorney General's Office were dismissed from the meeting at 6:57PM.

#### **Officer Elections**

Board was given the opportunity to vote.

Commissioner Jantz moved that Commissioner Kneifel continue as the Board Chair. Commissioner Schneck seconded. Motion passes unanimously.

Commissioner Kneifel moved that Commissioner Baesler be appointed as the new Vice Chair of the Board. Commissioner Schneck seconded. Motion carries unanimously.

Commissioner Schneck moved that Commissioner Jantz be appointed as the new Board Secretary. Commissioner Kneifel seconded. Motion passes unanimously.

## 2017 Board Meeting Calendar

Commissioner Jantz moved to approve the proposed 2017 board calendar. Commissioner Schneck seconded. Motion passes unanimously.
