Commissioner Calderon moved to accept the minutes from December 6, 2018 and Commissioner Garcia seconded. The motion passed unanimously.

Chairs Report/Summary of Current Events Discussion only

Commissioner Jantz welcomed back to the board – recently re-appointed.

Executive Director's Update/Summary of Events Discussion only

Director Collins was invited to attend the inauguration at the Capitol. She was also recommended by a legislator to be one of four speakers at The Women's March Phoenix - the first deaf woman to be featured as a keynote speaker.

Even though we were hoping for more people to come to the open house, we did get a lot of the new freshmen legislators attend. Commissioner Williams and Director Collins were able to meet with their local legislators.

The agency provides various training, but specifically child safety training is so important for people that interact with deaf adults with children for a better understanding of their culture.

Pertaining to the budget, one full time position was requested and approved – Director of Public Policy.

The Commission has a contract agreement with U of A to do a needs assessment for Interpreter Licensure, quality of services and are in the beginning stages of that process.

The Commission is also in the middle of transitioning to a new website as of Wednesday, February 20th.

<u>Arizona DES/AZ Early Intervention Program – Seeks Public Comment – ACDHH position Discussion</u> Only

The Department of Economic Security (DES) is a very large department. One of the components of their program is early intervention services 0 to 3. They have released a call for public comments about the program and this item is placed on the agenda so the public (in the audience) can comment about what we need to consider including in our comments (deadline is March).

2019 Legislative Update Discussion only

Daniella gave the following state legislative update:

After several years of advocating for live captioning of the Governor's State of the State Address and opening day ceremony, it happened for the first time this year.

ACDHH held a successful opening day open house for legislators where they were able to learn what the Commission does and experience some of the equipment available to the community. Commissioners Huch, Vanover and Williams were on hand to assist.

The current bills being monitored are:

HB2566: Peace Office Training; Requirements

Current language related to training is broad and how they prefer it, but would like to work with the Commission to add a component to their curriculum pertaining to peace officers trained on protocol for interacting with individuals with communication deficits (deafness, developmental disabilities or mental illness) – without changing statute.

HB2532: Critical Health Information; Emergency Responders

The purpose of the legislation is to give emergency responders more tools to stay informed and help save lives by way of critical health information (individuals must participate in the program). This bill should be making its way to the House floor soon.

HB2616: Voting Bill

This bill would make it a class 1 misdemeanor for anyone to pay or be paid to do voter registration - class 1 is the most serious misdemeanor and is on the same level as assault and shoplifting. (Many non-profit organizations and disability groups help register people to vote)

In regards to the sexual assault at Hacienda Healthcare:

The Commission was part of a stakeholder group that gave input on a couple of bills introduced by Representative Longdon: HB2665 and HB2666. HB2665 related to educating and training persons employed to care for vulnerable adults on the signs of neglect and abuse (including sexual abuse). HB2666

related to the duty to report a reasonable belief that a vulnerable adult has been the victim of abuse, neglect or exploitation. These bills will not make it through the process, but the stakeholders intend to continue working on the issue over the summer.

Rip gave the following federal legislative update:

The federal government's drought contingency plans for the seven western states part of the Colorado River that sets ground rules on how each state will manage shortages. Arizona passed it, but there are still a bunch of internal agreements that have to take place in Arizona, time will tell.

Tax Conformity Act is a routine process for Arizona to pass a bill every year that syncs the Arizona statutes with federal statutes. This year there is an odd situation with this "syncing" process that brings Arizona with a windfall close to \$200 million. Currently there is a stalemate in the state legislature as to this tax issue and cold make for a long session.

<u>Licensure Complaint Process – Informal Resolution Discussion only</u>

A new process has been implemented with the help of the Assistant Attorney General Jo-Ann Handy.

Delegation of Board Authority to Decide Informal Settlements - Discussion/Action

The board needs to go on record to formalize the authority to the agency – specifically the Executive Director (back up of the Deputy Director) to have the authority if any issues arise around licensure settlement that we have the authority to be a part of the process working with the Attorney General's office.

A discussion ensued between the Assistant Attorney General, Jo-Ann Handy and various board members regarding the desire to have board representation as a part of the process.

MOTION: Jantz motions regarding Statue 41-1092.06 that we designate authority for of representation of the board for informal settlement process. That designee will be the Executive Director of the Commission with the Deputy Director to stand in the case of an emergency for this settlement process. Commissioner Webster seconded – Benton opposed. Motion carries.

Commissioner Jantz motioned to dismiss the complaint against Haley Ritter and Commissioner Reichman seconded. Motion passed unanimously.

Regarding Posedly:

Commissioner Jantz would like to note the complaint for future reference if necessary.

Commissioner Jantz motioned to dismiss allegations 1 and 2 with a civil penalty on allegation 3 in the amount of \$100 for breaking statute. Commissioner Reichman seconded. Motion passed unanimously.

Second motion by Commissioner Jantz for an option of informal settlement at the discretion of the Executive Director, seconded by Commissioner Vanover. Motion amended by Commissioner Benton that in lieu of a monetary fine there be an increase in CEU hours at the discretion of the Executive Director, seconded by Commissioner Reichman. Motion passed unanimously.

Regarding Hudon:

Commissioner Benton motioned to accept staff recommendation to send a courtesy letter to the interpreter and the school. Commissioner Calderon seconded. Motion passed with 2 abstained.

Commissioner Vanover motioned to accept staff recommendation to send a courtesy letter to the interpreter and the school. Commissioner Sienko seconded. Motion passed with 2 abstained.

Regarding Young:

Regarding the Stone complaint:

Commissioner Jantz motioned for a civil penalty on each allegation 1, 2 and 3 of \$300 civil penalty for each (\$900) and for the 4th allegation a civil penalty of \$100 for a total of \$1000 with an option of a settlement with no more than a 25% reduction in fine. Commissioner Reichman seconded. Commissioner Benton opposed, motion carries.

Regarding the McLaws complaint:

Commissioner Benton motioned for a civil penalty of \$300 on each allegation. Commissioner Jantz seconded. Motion passed unanimously.

Second motion by Commissioner Benton with an option of settlement of no more than 25% reduction of total fine imposed, Commissioner Vanover second. All in favor, motion carries.

ILC Update Discussion Only

Commissioner Benton noted 50 applications were approved today.

Arizona State Schools for the Deaf and Blind Update Discussion Only

Commissioner Reichman gave the ASDB update. ASDB was allocated \$1.6 million for additional staff for early intervention services - The money was for 21 more staff members, which was recently negotiated down to 20 due to hiring more experienced teachers that cost a bit more than predicted. So far ASDB has 17 and will need to hire 3 more. The new teachers are matched with mentors and is working out well.

A system is in place for reviewing curriculums and implementing them on a yearly basis (last year was English, Math this Fall, then science and then social studies).

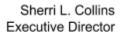

Executive Director's Update/Summary of Events Discussion only

Director Collins highlighted a few key areas:

- The Commission continues to provide law enforcement training and recently presented to the Chiefs
 of Police and they have recognized the need for this training and want to partner with ACDHH.
 They want to develop video tapes (they have a full-house studio production) and they offered their
 resources to help develop training. Tomorrow is a meeting with the Sheriff's association.
- The Commission filed a comment on early intervention with the Department of Economic Security As part of their grant requirements, they have to submit a report to the federal early intervention program. ACDHH worked with the community stakeholders and there was a strong presence from the Deaf community. Now waiting to hear the next steps after they address the public comments.
- Funding received last year for SSP services and the DeafBlind program is an area ACDHH is
 focusing on and learning from the community as to how to better serve the adults as this is an
 underserved population, actually there are basically no services to the DeafBlind (including low
 vision) and hard of hearing adults. There were some issues with SSP copy signing, which is a
 violation of our interpreter licensure law and we have let the SSP's know it is a violation.



2019 Legislative Update Discussion only

Rip Wilson gave the following state legislative update:

Shared that Daniella Smith has taken another opportunity and would not be providing any further legislative updates with him.

We are currently in day 123 of this session with no end in sight. The big stumbling block has been the budget, combined with the issues produced by the federal tax legislation and the manner in which the state of Arizona complies to the federal tax law. As it stands, it produces about \$150 million windfall to the state and the majority party (Republicans) are disputing what to do with that excess monies.

The current bills that impact us at this stage are:

HB2569: This is the so-called, licensing reciprocity bill that basically says that if you have a professional license from another state, Arizona will honor that license and you can practice your licensed profession here. The important part is that it doesn't cover every license and this Commission licenses interpreters and they're not included in that legislation - nothing has changed how the Commission will conduct its examination and licensing procedure.

HB2558: This bill called for an appropriation, FTE, a personnel position for a statewide ADA coordinator - develop and monitor an ADA statewide compliance plan and would have given all of the disability community a point of contact that doesn't exist today. It got through 2 committees in the House, but it never moved past that point. It was never brought to the floor for a vote. It's sitting there and nothing has happened to it since February.

Finally, the texting while driving bill was passed - if you have a handheld device, you can't be holding it while you're driving. You don't have to be actively using it and that's important to know. Ticketing will start January 1, 2020.

<u>Delegation of Board Authority to Decide Informal Settlements – Discussion/Action</u>

Assistant Attorney General, Jo-Ann Handy explained the purpose of this agenda item is that when the board has a substantiated complaint that will trigger a hearing for the licensee, certain (delegated) members of the executive team would be able to reach out to the licensee with a settlement agreement before the complaint is issued. This is a very common practice for agencies to do.

A discussion ensued between the Assistant Attorney General and various board members regarding delegated board authority.

Due to phone connectivity issues, there was a short break from 5:15 p.m. to 5:20 p.m.

More discussion between the Assistant Attorney General, Carmen Green Smith and various board members regarding delegated board authority.





MOTION: Commissioner Jantz motions for the Assistant Attorney General prepare a complaint process flowchart for board to review at the next board meeting. Commissioner Webster seconded. The motion passed unanimously.

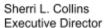

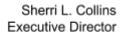

Sunset Review response

Sherri Collins gave a brief history about the last sunset review. The last review involved the receipt of \$750,000 in non- lapsing funds for Interpreter training programs that have been carefully used for DeafBlind, CDIs and Interpreters. This year may request for more funds from Legislature, possibly for DeafBlind interpreting training and/or licensing or certification/licensing of interpreting agencies. Betty will be asked to look into the certification/licensing of the interpreting agencies. Sherri Collins highlighted that the ASL certiciation requirement for schools will be recommended to be removed from the statute because the commission does not have oversight in schools. The Sunset response is due September 1, 2019. Feedback was requested on the sunset review. None received from the board. RFP(request for proposal) will go out next month. Staff, Curtis Humphries explained there is an expectation that the telecommunications rate will increase. This is reflected in the budget for FY2021. Salary increase for ACDHH staff will be requested.

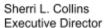

Chair Kneifel noted that there is still one Deaf Representative position open and encouraged the board members to vote tonight for the annual board seats for Chair, Vice Chair and Secretary because her commission expires at the end of January - next board meeting being held in February 2020.

Executive Director's Update/Summary of Events: Discussion only

Director Collins first introduced three new faces to the ACDHH staff:

- Betty McIntire, Director of Public Policy and Community Relations
- Christy Abrams, Hard of Hearing Specialist
- Laricsa Herrera, Business Operations Assistant

With Betty on the team, she will assist filing on the federal level and in fact, filed her first FCC comments related to IPCTS - automatic speech recognition for Internet Protocol-Captioned Telephone Service. This is a hot issue in the relay business because the FCC is considering transferring the cost of IPCTS service to the individual states. This filing was important because now we can participate on the federal level and be an advocate for the community in our state.



In regards to community relations, over the years, ACDHH has a contract with a P.R. firm - currently with Lavidge and they've done an outstanding job for our agency. Now that we've expanded the role in our office with Betty's position to include communication, we are going to try something different for the 2020 year. We are focusing on a campaign based on the town hall meetings we held last Spring. While all of the cities we visited are important, we are choosing to focus on Yuma for the next year due to issues that need our attention there.

One key area of focus will be on employment and shifting from a P.R. contract to more of a campaign opportunity will help bring attention to this in key areas of the state.

We will be moving the board meeting location outside of Phoenix to Yuma this year (versus Tucson) as this is aligned with our focus for 2020.

A positive outcome from involvement in the AdHOC committee this year, which focuses on vulnerable adults, was being able to make recommendations for the legislation to consider to introduce bills, if any, in the 2020 legislative session.

Sherri Collins won the ATHENA Award from the Greater Phoenix Chamber, which recognizes and celebrates the achievements of business women across the Greater Phoenix region. She was recognized as a leader in the Public Sector.

A correction was noted in the financial part of her report that should have reflected fiscal year 2020 and not 2019. She also mentioned that the relay service contract expires at the end of the year, but the state decided to extend that contract for another six months. Curtis Humpries is working very closely with the procurement office before we release a request for proposal in early 2020.

Annual Report: Discussion/Action

We are moving through our Sunset as we speak, but our Sunrise recommendation from the Senate occurred a couple of weeks ago pertaining to language acquisition - LEAD K implementation and just maintaining our current status with our budget - This

being an election year, we (ACDHH) wants to be more on a supportive defensive, making sure nobody depletes us.

Rip Wilson gave the following update:

What Sherri would like to accomplish in the next year is to get in front of as many members of our federal delegation, the two Senators and nine congressmen and educate them (better) about who we are, who the agency is and what it does and the community it serves.

The second component is to identify legislation that (at the federal level) has a significant impact on the communities we serve - trying to do a better job of engaging on those pieces of the legislation as the best opportunities to educate our congressional delegation.

A discussion ensued between Chair Kneifel and Betty McIntire concerning her question about the impact of the Alice Cogswell legislation.

<u>Sunset Review and Sunrise Recommendation / Early Intervention Language Acquisition:</u> Discussion/Action

The Commission sunsets on June 30, 2020 and what that means is every agency, board and commission has this (a sunset) - it is to make sure that we are doing the work we said we are doing, that we are beholden to the taxpayer and to the citizens of this state and doing the job we said we would do.

So this process is having a sunset hearings in both chambers, Senate and the House. At the beginning of November, we had our hearing in the Senate. It was a great hearing and we were recommended for our Sunrise unanimously. Now we await our hearing in the House, which may be in January.

By January 27th, each chamber has to recommend and propose their report to the respective chambers, to the Speaker of the House and to the President of the Senate. The chairs of each committee will sponsor our sunrise recommendation legislation - we are requesting the following:

- Senator Brophy McGee, Chair of the Health and Human Services Committee in the Senate to include deafblind in our duty statute. Arizona Revised Statute 36-1944.
- We are making a modification to number 8, the Newborn Child Hearing Loss Screening Program stating we will continue to support that program as a Commission.
- Update to number 9 around early intervention giving the Commission the authority to study language acquisition and literacy development for deaf and hard of hearing children.

A discussion ensued between Commissioner Jantz, Betty and Sherri concerning adding the Department of Education to number 2, which was determined not needed.

A discussion ensued between Commissioner Jantz, Chair Kneifel and Betty concerning number 9 and adding the Department of Health, which was determined not needed.

Commission Reichman summarized what the Commission was asking of the board, which are two things:

- 1. A Bill for a task force to be implemented
- 2. For the Sunrise to include some of that recent language mentioned including language acquisition, early intervention, etc.

Commissioner Jantz asked what the task force membership would look like and Betty responded that the mandated members would be DES, ASDB and ADE - the three main entities. Other community members would be invited such as: parents of deaf and hard of hearing children, deaf mentors, school districts. Betty noted that it's important to use the Sunrise to mandate the three entities attendance (via the law).

Chair Kneifel noted that what ACDHH is doing is establishing the authority to oversee this and make sure that the right people are at the table. Betty confirmed.

Commissioner Reichman moved that ACDHH submit the Bill to establish a task force to the state legislature and Commissioner Calderon seconded. The motion passed unanimously.

Commissioner Huch moved to accept the proposed sunrise changes as written and Commissioner Calderon seconded. The motion passed unanimously.

Delegation of Board Authority to Decide Informal Settlements: Discussion/Action

Assistant Attorney General, Jo-Ann Handy explained to the board that they can go into executive session and discuss amongst themselves settlement, but then also be a place where the board would instruct the attorney on the settlement framework; However, the actual introduction of a motion or voting on the motion has to be done in public session. That way the Commission can protect its attorney-client privilege operating in executive session.

As far as delegating authority, the Commission could delegate the authority for settlement negotiations to the subcommittee of licensing, but the same rules would apply for the licensing committee as stated above with going into executive session. The board could also discuss amongst themselves the framework for settlement and then delegate that authority to the attorney or a member of the executive staff.

Commissioner Jantz suggested that the board could wait for the next opportunity when there are fines that they need to set, go into executive session and discuss the framework of the settlement and move forward with delegating authority at that time so the board can see how it works in a real-life scenario. Commissioner Sienko and Benton agreed.

Chair Kneifel heard no motions from the board and moved to take this delegation as it comes in the future.
