2020 Legislative Update: Discussion Only

Betty McEntire reported the following:

This week is the last week for all Bills to be heard before they are deemed dead. Next week is cross over week. This is when the Senate bills go to the House and the House bills go to the Senate. We are expecting a budget next week. Both of our bills, 1055 and 1056 cleared the Senate. If no budget, there will be a second reading.

SB1055 is our Sunrise bill where we are modifying our Agency duties to include the DeafBlind along with a definition. It needs to pass through the House then it will go to the Governor. If there are no changes, it will not go back to the Senate.

We made recommendations as it relates to newborn screenings.

Legislative update in the Senate. Senator Pace believed the definition of DeafBlind was not technical enough. He wanted a clarification on the term Environmental and why that was important. Changes were made and now it is close to the definition of DeafBlind in the Helen Keller Act.

Weekly email updates are sent out on bills that may affect our communities. We have monthly update videos as well.

March 3, 2020 is world hearing day. Executive Director, Sherri Collins will sign the Pledge of Allegiance in the House. Students from ASDB will sign the Pledge in the Senate.

We will have CART and interpreters.

RIP Wilson reported the following:

Betty has given us a different level of engagement at the capitol.

Federal Report: nothing moves quickly in Washington D.C. General observation: there are discussions and consideration to make Social Security and disability requirements more difficult as well as changes to Medicaid benefits. This will negatively affect our constituents.

Legislative: I am watching a few bills if successful H1393 and S1423 change hearing, vision, and dental benefits for Medicare and Medicaid.

House Resolution 4932 expands access to Telehealth. House Resolution 4056 and S2446 Medicare amendment will make audiology services eligible

HR3866-If a Veteran develops hearing loss or Tinnitis, treatment will be covered by their VA benefits.

Regulatory side: FCC has not had a lot of movement. Sherri Collins has met with FCC in person and by phone on reimbursement rates.

There is a debate over using live or software recognition. FCC has also discussed moving all responsibilities to the states. That has currently stalled. Now it is in an open comment period on universal services and deafblind equipment.

The Jan 30th FCC had a meeting to deal with VRS and Call Assistants for interpreters working at home. There was also a discussion on rules for handset capabilities.

Director Collins thanked Betty McEntire and RIP Wilson for working in partnership with ASDB and Public Policy to make sure our vision is successful.

Sherri Collins - Page two (2) of your books are the top five (5) Agency Goals. At the next board meeting I will give a quarterly update.

Sherri Collins showed and explained the Agency's American Girl 2020 Doll of the year, Joss. She is Hard of Hearing and comes with accessories. Sherri Collins was interviewed about the doll. The doll's kit comes with an ASL guide. This is good for ASL and hearing aid exposure. The Agency has an extra Doll that will be kept to entertain children who come in the office.

Executive team level is working on a document that will define communication in different settings. This will be used in our curriculum training in Public Safety, Healthcare, and with the Ombudsmen. This is a way to introduce ourselves by offering our training.

Community Engagement Liaison and Betty McEntire will help support the agency with new partners. We are working with Arizona Health Care Cost Containment System (AHCCCS) to make sure the information on their website is accessible.

The Agency had a few Noisy Toys segments during the holidays - hearing health protection.

Arizona Relay Service Contracts are being reviewed. Hope to announce the new vendor by the end of April.

Financial report - nothing new, but Curtis Humphries is here to answer questions.

Commissioner Benton - questioned the Executive Director's work with LEAD K. Are appropriate standards being upheld?

Response Betty McEntire - we continue to meet with a small subgroup. At the last board meeting it was decided to make recommendations for language acquisition in the statute under 1056. We want to ensure that children have all of the tools they need for language acquisition.

Commissioner Benton admonished Betty McEntire to remember the Northern part of the state when collecting data. Betty McEntire acknowledged Commissioner Benton's concern and assured that would be included in the Agency's our rural outreach.

Interpreter Complaint(s)/Inquiries

Recommendation: dismiss due to unsubstantiated evidence

question - This is not the first complaint of a similar nature. Do we need to question other staff involved? Emmett Hassen - No other person was there. It was a "He said/She said" situation.

Commissioner Reichmen moved to dismiss the complaint. Commissioner Calderon seconded. The motion passed unanimously.

Commissioner Benton question - When we have complaints, would it be possible to share more background information? Example, first or second complaint.

Emmett Hassen asked for clarification

Commissioner Benton - Previous complaints need to be brought up as needed

Assistant Attorney General, Krysta Liveris - In terms of determining the nature of the issue, a previous complaint would not be relevant information to consider even if the complaint was accurate. If it was a credible complaint, the Commission could determine the appropriate action.

Commissioner Benton - because the complaint was unsubstantiated then we cannot look at past behavior

Assistant Attorney General, Krysta Liveris - We need to look at each case individually. She left the meeting at 5:29 PM.

Licensure Extensions

Carmen Smith Green clarified what is meant by some of the flexibility that ACDHH staff is asking the board for, with regard to individual applications during the COVID-19 situation. In our general rule, there is a standard 120 day extension that can be provided to any applicant in any category upon request when they have incomplete information or if they don't meet some category of the criteria.

2020 Legislative Update

Betty McEntire reviewed the legislative session. On March 13, 2020 the legislative session recessed due to the COVID-19 virus. ACDHH's agency continuation bill, SB1055, was signed into law on March 13, 2020. ACDHH's SB 1056, which was the bill that added DeafBlind to the agency's statutory services and also added the language acquisition committee to the agency's statutory responsibilities, was not passed prior the halt of the legislative session. This bill will have to be reintroduced during the 2021 legislative session.

The Governor is expected to announce a special legislative session after July 2020 to address COVID-19 related issues. Bills not related to COVID-19 will be addressed during the next legislative session beginning in 2021.
